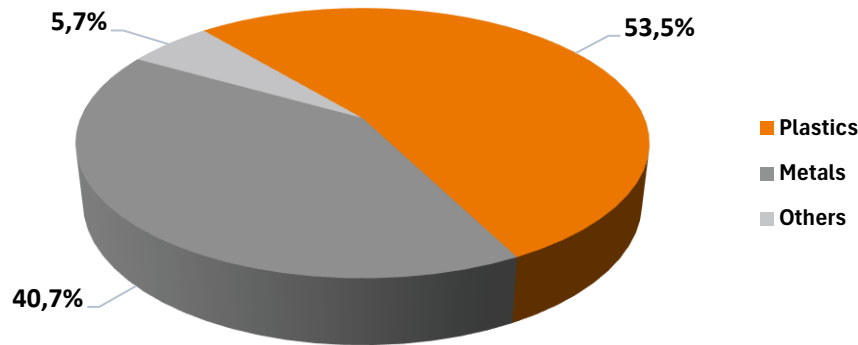

Additional Environmental Information

Manufacture	This stage includes the manufacturing of the product and its packaging as well as the transport to the manufacturer's last logistics platform located in Hörselbach-Hainich (Germany). The final assembly site is located in Romania. Transport packaging, used in addition to product packaging when required for delivery, is excluded from the system boundaries.
Distribution	The shipment is made from the distribution centre to the customer by truck. The transport route to the customer was assumed to be 3500 km by lorry.
Installation	Only the disposal of the packaging is considered in this phase, as the installation is carried out manually with non-electrical tools.
Use	No maintenance or utilities are required during use. The power consumption was calculated according to the use scenario below.
End of Life	The end-of-life stage is modelled based on the data from Eurostat. The transport route to the disposal company was assumed to be 1000 km by lorry.
