As part of the changeover from UL 20233 to UL 20549 raw cables, the outer diameter must be adjusted to the new UL style.

With this product change, the outer diameters are reduced in accordance with the table below.

All other technical specifications, such as temperature range, bending radii, etc., remain identical.

If the overmolded cable has UL approval according to UL 2238, this remains valid without restriction.
